Course Description

Credits: 2-3: Prereg: Graduate Standing

<u>Meeting Location:</u> Mehrhof Hall, room 102, BLDG 550. Time and day will be decided after classes start to accommodate all students' class schedules.

Learning Objectives: At the conclusion of this course, the student will be able to:

- Critically review pertinent journal articles and lead in-depth discussions.
- Evaluate the role of editorial boards and journal rubrics for manuscript acceptance.
- Assess small scale and commercial native plant propagation and production systems.
- Gain an understanding and experience of native plant venues such the Association of Florida Native Nurseries, Florida Wildflower Cooperative, Florida Native Plant Society, and others.
- Determine how native plant grants are prioritized for funding and rubric metrics.

Textbook- none. All materials will be posted in canvas.

Student Evaluation

Journal Club: Each week we will critically evaluate and discuss a journal article or grant proposal related to native plant horticulture or science. This is student centered, and each student will be responsible for finding a paper to lead the discussion for a given week.

Field Trips: Every 3 weeks, we will visit a native plant facility (nurseries, gardens, trade shows, etc). This is student centered and each student will be responsible for organizing a trip for the class.

In-Class Recording

Students are allowed to record video or audio of class lectures. However, the purposes for which these recordings may be used are strictly controlled. The only allowable purposes are (1) for personal education use, (2) in connection with a complaint to the university, or (3) as evidence in, or in preparation for, a criminal or civil proceeding. All other purposes are prohibited. Specifically, students may not publish recorded lectures without the written consent of the instructor. A "class lecture" is an educational presentation intended to inform or teach enrolled students about a particular subject, including any instructor-led discussions that form part of the presentation, and deliver by an instructor hired or appointed by the University, or by a quest instructor, as part of a University of Florida course. A class lecture does not include lab sessions, student presentations, field trips, clinical presentation such as patient history, academic exercises involving solely student participation, assessments (quizzes, tests, exams), conversations between students in the class or between a student and the faculty or quest lecturer during a class session. Publication without permission of the instructor is prohibited. To "publish" means to share, transmit, circulate, distribute, or provide access to a recording, regardless, of format or medium, to another person (or persons), including but not limited to another student within the same class section. Additionally, a recording, or transcript of a recording, is considered published if it is posted on or uploaded to, in whole or in part, any media platform, including but not limited to social media, book, magazine, newspaper, leaflet, or third-party note/tutoring services. A student who publishes a recording without written consent may be subject to a civil cause of action instituted by a person injured by the publication and/or discipline under UF Regulation 4.040 Student Honor Code and Student Conduct Code.
